

## Terms of Use

This Terms of Use covers Customer and its customers, agents and users ("Users") use of and access to the MetaFarms Services and Platform.

Customer will not permit any of its employees, agents, or other users under its control, to do any of the following in connection with MetaFarms Services ("Prohibited Activities"):

- take any action that presents a material security risk or will interfere materially with the proper continued operation of MetaFarms' Servers or MetaFarms' ability to provide Services
- transmit viruses, bugs, time bombs or other corrupt data
- engage in any activities or actions that infringe or misappropriate the intellectual property rights
  of others, including, but not limited to, using third party copyrighted materials without
  appropriate permission, using third party trademarks without appropriate permission or
  attribution, and using or distributing third party information protected as a trade secret
  information in violation of a duty of confidentiality
- engage in any activities or actions that would violate the personal privacy rights of others, including, but not limited to, collecting and distributing information about Internet users without their permission, except as permitted by applicable law
- send, post or host harassing, abusive, libelous or obscene materials or assist in any similar activities related thereto;
- intentionally omit, delete, forge or misrepresent transmission information, including headers, return mailing and Internet protocol addresses
- engage in any activities or actions intended to withhold or cloak Customer's or its Users; identity or contact information
- send unsolicited commercial messages or communications in any form ("SPAM")
- use the MetaFarms Services for any illegal purposes, in violation of any applicable laws or regulations or in violation of the rules of any other service providers, web sites, chat rooms or the like
- share login credentials with others
- assist or permit any persons in engaging in any of the activities described above.

If Customer becomes aware of any Prohibited Activities, Customer will use best efforts to remedy such Prohibited Activities immediately, including, if necessary, limiting or terminating User's access to Customer's online facilities.



## Prohibited Use:

- You may not access or use the Services or platform for purposes of monitoring activity, performance, or functionality, or for any other benchmarking or competitive purposes. You agree not to use the Services or platform to develop a competing product or service, or otherwise engage in competitive analysis.
- You agree not to decompile, reverse engineer, disassemble, attempt to derive the source code of, or otherwise exploit any part of the Services. Automated data scraping or extraction for competitive purposes is strictly prohibited.
- We reserve the right to suspend or terminate your access to the Services and/or Platform if we reasonably believe you are a competitor or are accessing the platform on behalf of a competitor.
- By using the Services and accessing the platform, you represent and warrant that you are not a direct or indirect competitor of MetaFarms, and you are not accessing the Services on behalf of, or for the benefit of, any such competitor.
- Any unauthorized access or use of the Services or platform constitutes a material breach of this Terms of Use and may subject you to civil and/or criminal liability, including injunctive relief and monetary damages.
