## Compliance

Compliance is a way to track the Prop 12 compliance of sows and pigs from mating to wean and moving pigs into a finish group. A few things to note to use this process are:

- Fosters must be done between two prop 12 compliant sows or wean pigs will not be considered compliant.
  - There is no warning for fostering between a compliant a non-compliant sow. Customers must keep track of this themselves.
- To track compliance for pigs moving into a finish or nursery group, use the Create Movements from Unassigned events menu item.

There is setup required prior to being able to use Compliance to track sows.

First the Compliance Flag must be Setup in Sow flags:

- Sow > Setup > Attributes > Sow Flags
- Add a Sow Flag to the table
- Make sure the Compliance check box is ticked.

Next, make sure your mating event has the option to record a Sow Flag both on Sow Mobile and on the Web, if it does not contact MetaFarms support so it can be added.

For a Sow to be considered compliant, the flag **MUST** be applied to the Mating event.
