## **Release Notes**

A MetaFarms software release will be implemented on February 18, 2025. **100**% of the below features and defects came from feedback from our customers. Please be sure to continue with your questions/comments on this release and any future enhancements you would like to see!

Below are some of the enhancements available and defects that were fixed.

\*\* Note: Additions to reports can result in changing column headers, inserting new columns and rows, and may affect any macros you have for that report. To help reduce the impact on custom written macros, we suggest users unhide Row 1 and reference the column name vs referencing the letter of the column in the macro.

New columns added to reports will be visible in the MetaFarms Full version and hidden in the MetaFarms Summary version.

## Feature 6312: Adding Prop 12 Payment Field to Wholestone API

The Wholestone API has been updated to now bring in the Prop12 premium payments made to those customers that send Prop12 compliant pigs.

### **Feature 6787: Pending Close Closeout Summary Changes**

When using the Pending Close functionality, the following changes have been made:

- 1. Added a report control named "Include Pending Closed Groups". This field is defaulted to false, but when it is checked, groups that are Pending Close will be included in the Closeout Summary for the selected date range and run by options.
- 2. Current Inventory added as column AE to show inventory of each group when the report is run.
- 3. Pending Close added as column A. An X designates that the group is Pending Close.

## Feature 6870: Pending Close Combined Group Closeout Changes

When using the Pending Close functionality, the following changes have been made:

- When in Report By: Site / Closed Date, added a report control named "Include Pending Closed Groups". This field is defaulted to false, but when it is checked, groups that are Pending Close will be included in the Combined Closeout Summary for the selected site and date range.
- 2. When in Report By: Groups, groups that are Pending Close have a \* at the end to signify that they are pending close.
- 3. Group Status added as row 20 to show which groups are Closed and which are Pending Close on the report.

## **Feature 6871: Pending Close Group Ranking Changes**

When using the Pending Close functionality, the following changes have been made:

- 1. Added a report control named "Include Pending Closed Groups". This field is defaulted to false, but when it is checked, groups that are Pending Close will be included in the comparison collection (groups in white).
- 2. A Pending Close group can also be selected as the target group from the list. They will be shown as status A but have a "Close Date" of the last event for the group.

## Defect 6781: Sow Performance Monitor – Breed Batch Calculating PWMFY Total / Average Field

Total/Average column is now displaying the correct average for PWMFY and PWFY when running the Sow Performance Monitor Breed Batch report.



## Defect 6974: Taking Current Status as Arrival Status on Transfers via Mobile

Sow's status will always be kept after a transfer event is done from the mobile app.

## Defect 6921: Nulling Room and Pen for Mortality Records on Group Update

Changing the group details no longer nulls the room and pens on mortality records.

## **Defect 6955: Credit and Rebill Logic Error**

An issue with the Credit and Rebill function for a movement has been addressed. All expenses will be handled correctly going forward.

## Defect 6994: Total Expected Premium Field Split on the Split Load Logic

An issue was fixed that occurred if sending pigs to the Smithfield Sioux Falls plant where a starting premium of \$3 is given to each carcass. The calculation of the Total Expected Premium was not being split if the load was split.
